In August, 111 noise complaint responses were completed from 966 noise complaints, with 95 of those by email and 16 by telephone.

In August 816 complaints were received from 7:00 a.m. – 9:59 p.m. (84%) 150 complaints were received from 10:00 p.m. – 6:59 a.m. (16%)

In August props accounted for 87% of the complaints by aircraft type; jets accounted for 12% of the complaints, and helicopters caused 1%. Comparatively, Year to Date figures showed propellers had caused 90% of the complaints; jets caused 9%, and helicopters caused 1%

In August, departures were responsible for 47% of the complaints, training was responsible for 39% of the complaints, , and arrivals were responsible for 14% of the complaints. Comparatively, Year to Date figures showed training had caused 44% of the complaints, departures had caused 37%, and arrivals had caused 19%.

A graph was provided showing the **August number of complaints by the hour** in which they were made, with peaks in the 6:00 a.m. – 10:00 a.m. time period, followed by a rather dramatic decrease after 10:00 a.m. through the evening hours.

The map of household locations and numbers of complaints was included, as was the August Radar Track Density Map.

Comments made regarding the Noise Report were as follows: YTD Operations are down as compared to 2024. YTD Complaints are also down as compared to 2024. YTD #1 Household for complaints has changed to OTHER (Elbert County / 3 Towers Training area). Complaint by Type of Operation has changed as DEPARTURES (47%) surpassed TRAINING (39%) in the month of August. In the month of August, the Complaints received by Hour again spiked in the early morning hours 7AM with most complaints during the 6 AM – 10 AM hours. It appears that more jets are being "seen" than flights schools. JXS has had 120 operations to date and has received 2 complaints. On the day of the 2 complaints flights were in a North flow pattern due to weather. Variable to consider – Air Traffic Controller staffing may be affecting pattern traffic and no touch and go operations, thus a decrease of traffic in the study area. The government shut down should not affect operations at Centennial airport – safety standards override "volume" or staffing.

Comments made regarding the Portable Noise Report were as follows: Data is consistent, although July is the busiest month. 3 Towers is experiencing an average of 13 overflights per day. Total Aircraft Noise Events in July recorded much higher while June and August are comparable numbers. Zach will check the data recorded in July for an error. Note that the Decibel Ranges experienced in 3 Towers is similar to the permanent monitors such as Castle Pines and Sagebrush Park – much closer to the airport. Next the Portable Monitor will be positioned one training box to the East to measure activity.

6. PUBLIC COMMENT:

A. MEETING ATTENDEES/VIRTUAL ATTENDEES -

- 1. Randy Johnson from Louviers recorded 586 planes in September, mostly training. The numbers vary greatly day to day ex: September 18th there were 42 and September 22nd there was only 1 due to foggy weather. He submitted 66-70 complaints to Centennial. Planes continue to turn and fly directly over his area as it seems that they are purposely flying over Louviers. Randy asked two questions: do the control towers say anything about the number of training planes? Portable monitors register community events, do the permanent monitors register them as well? (Answered by Airport Staff yes, permanent monitors do register community events. The data is separated.)
- 2. Laurie Lauletta-Boshart from Parker, Unincorporated Douglas County. Laurie lives on acreage. The 5-7AM spike in complaints received by hour on the Monthly Noise Report is due to her area. They are experiencing a major disturbance. Volunteer Fly Quiet Hours need to be respected. Even flights at 1000 feet above their homes are loud. This activity was not noticeable in 2024. Is there an update on the proposed new route to the training areas using HWY 83 & 86? (Answered by Airport Staff it is still a path to the training boxes. being used, although VF rules make it difficult to be a 2-way corridor for flight traffic). Laurie as to please share the results of the Quarterly Flight School Meetings and please be a considerate neighbor with Fly Quiet Hours incentivize pilots to do so.

7. CACNR STUDY GROUP COMMITTEE:

Chair Brad Pierce reported the group was continuing to meet and was working with the vendor on the dashboard. The matrix set for the dashboard will include the following:

8. **EXECUTIVE COMMTTEE:**

- A. **ACPAA** Pam Thompson had provided a written report of the September 11th ACPAA meeting. She noted a Public Hearing was held on two items: Aircraft Maintenance company & Aircraft Detailing company. New Wings of the Rockies Director, David Dickerson, was introduced.
- B. **WEBMASTER** Chris Eubanks indicated the website update will be reflected in the 2026 Budget. He is working with Zach Gabehart on writing an RFP for a new CACNR Website design.
- C. **WORK PROGRAM** Amy Tharp reported the group had completed the first round of organizing and prioritizing the work program. Chuck Darnell has streamlined items into a Draft 6 comprehensive table listing. All items have been categorized as either High, Medium or Low priority. More to come at later date.

9. AIRPORT DIRECTOR'S REPORT:

Mike Fronapfel reported that airport operations were down about 9.4% for the month and 11.1% compared to last year. However overall fuel sales increased 2.1%. 100 Unleaded R gas – ASTM certified for 2 aircrafts, 172R & S models. Continue to test on other aircraft, Goal is for 100R to be acceptable for 75% of the fleet.

Ongoing construction/ modernization of Tower. Also on the horizon, a Community Park with viewing tower in honor of Robert Oslinger located to the west of the Hanger Building.

Skies Academy did not reopen.

David Dickerson – appointed new director of Wing Over the Rockies.

EnviroSuite convention was hosted at Centennial Airport. Zach and Matt presented to group. The group was blown away by the noise work being done here at Centennial.

Partnership Meeting with Douglas County Mike Fronapfel presented on behalf of the airport. Economic impact of Centennial airport – airport supports over 9,200 jobs and generates a significant amount of revenue to the local economy.

Q3 2025 APA Flight School Safety & Noise Abatement Meeting Report was submitted:

Fourteen representatives from various flight schools participated, contributing to a highly engaged and productive session.

FAA Air Traffic Presentation

FAA Air Traffic Personnel led the safety portion of the meeting, presenting updates and operational changes relevant to Centennial Airport:

- Wrong Surface Landings: Attendees were briefed on potential factors for wrong surface landings, including safety considerations.
- Runway Operations: The FAA shared video clips illustrating best practices and areas of concern related to runway safety.

Noise Abatement Discussion

The noise abatement segment included several key updates and discussions:

- Airport staff review 2 key airport operational considerations including: Airport Winter Operations and Safe Taxi Procedures on Uncontrolled ramp areas.
- Q2 Noise Abatement Report Recap: A summary of noise trends, community feedback, and observations from the first quarter were presented.
- Practice Area Usage: Airport Staff reviewed the designated practice areas and discussed strategies for minimizing noise impact during training operations.
- Noise Abatement Guidelines: Participants were reminded of established noise abatement procedures.

Fly Quiet Dashboard Presentation

BridgeNet International delivered a detailed presentation on the development of the Fly Quiet Dashboard for APA. The presentation covered:

- Measured Metrics: Proposed data points to be tracked in the developed dashboard.
- Scoring Methodologies: Ideas for quantifying operator performance in relation to noise abatement goals.
- Project Timeline: Dashboard test period will begin Q4 2025 with dashboard launch expected around January 1, 2026.

Flight school representatives actively participated in the discussion, raising thoughtful questions and providing valuable feedback on potential implementation challenges and opportunities.

CACNR discussion was as follows: The Flight Schools were receptive of the Dashboard and collaborative in refining the "scoring" so that it would be most effective and fair for all. The Flights Schools were made aware of the "hot spots". These are the areas that we are experiencing the most complaints from. FAA is not responding to complaints regarding low altitude violations. These continue to occur. There has been no feedback from emails submitted to the FAA. Even though the FAA was present at this Q3 meeting they have pulled back by direction of current Administration. The Study Group has been pressing to get them back at the table - meeting with Washington DC representatives to encourage participation.

11. **NEW BUSINESS**: Demonstration of New Noise Website – Zach Gabehart.

Flights can be viewed over individual's home when address is entered.

Note: Altitude measured in 1000-foot increments. Example: chart does not necessarily mean flight is at 6000 feet but rather somewhere between 6000 and 7000 feet.

Discussion was held regarding the average noise levels at different altitudes and the statistics of the reduction of decibels by raising the altitude 500 feet. Typically change of 3 decibels requires doubling the distance.

12. PUBLIC COMMENT EXTENSION IF NEEDED: na

Flight Schools were urged not to perform ground reference maneuvers in training boxes.

Hot Spots were presented to Flight Schools,

Bill Wasmund: FAA cannot respond. Rocky Mountain / Air Traffic Manager have been directed to NOT engage in noise abatement issues. Noted David Dickerson's (Wings) impressive bio and community involvement. Wings Over the Rockies – Marines 250th Birthday Ball to be held on November 9th - material distributed and website available.

Amy Tharp: further elaborated on progress of Work Program and the documentation / organization being done by Chuck Darnell.

Commissioner Rhonda Fields: Community meeting involving 80 seniors as well as the DA and Arapahoe County Sheriff. Items of public concern included: Fraud, Public Safety, as well as Coordination with the FAA and 2 inquires regarding Airport Noise and noise management.
